Chairman McAfee opened the meeting at 7:00 pm and led the audience in the Pledge of Allegiance.

Trustee Johnson moved to approve the agenda and the consent agenda. Trustee Seefried seconded. All were in favor. Motion carried.

Trustee Seefried moved to approve the District Bills dated 2/14/2022. Trustee Johnson seconded. No further discussion. All were in favor. Motion carried.

Superintendent Buescher presented What's Right and her district report:

Superintendent Buescher presented information on the State Health Insurance and the estimated cost to the district.

Trustee Johnson moved to offer Susan Buescher a one (1) year superintendent contract for \$39,000.00. Trustee Seefried seconded. No further discussion. All were in favor. Motion carried
